## ANNUAL REPORT 1964-1965

The Warburg Institute Committee of Management was constituted for 1964-65 as Constitution of Committee

The Vice-Chancellor; the Chairman of Convocation; The Principal; Two representatives of the Warburg family (Mr. E. M. Warburg, Mr. A. Prag); The Chairman of the Academic Council; The Chairman of the Council for External Students; The Chairman of the Collegiate Council; The Director of the Institute; Prof. Sir Anthony Blunt; Prof. H. Buchthal; Prof. Sir William Coldstream; Prof. R. R. Darlington; Prof. C. Dionisotti; Prof. W. S. Maguinness; Prof. A. Momigliano; Prof. Kathleen Tillotson; Prof. E. G. Turner; Prof. F. Wormald; Prof. B. Ashmole; Dr. T. S. R. Boase; Prof. Edna Purdie (Chairman); Dr. G. F. Webb.

The honorary degrees of Doctor of Laws of the University of St. Andrews and of Doctor of Staff Letters of the University of Leeds were conferred on the Director during the session. In October he received the W. H. Smith & Son Annual Literary Award for his book Meditations on a Hobby Horse. During the Easter vacation he took up an appointment of four weeks as Walker Ames Professor at the University of Washington, Seattle.

Dr. Bartley resigned his Lectureship on I August 1964 on his appointment as Associate Professor at the University of California at La Jolla. He has been replaced by Mr. M. D. K. Baxandall who took up his appointment as Lecturer in Renaissance Studies on I February 1965.

Professor Buchthal was Resident Visiting Scholar at Dumbarton Oaks during the Easter vacation. He resigned from the Institute at the end of the session on his appointment to a Chair at the New York University Institute of Fine Arts. His resignation was accepted with the greatest regret. Professor Buchthal had been associated with the Institute for over thirty years since his student days and rendered invaluable services as its Librarian, as a teacher, and through his research. To fill the gap left by his departure, Dr. Kurz has been appointed to the newly established Chair of the History of the Classical Tradition with special reference to the Near East, tenable at the Institute from 1 October 1965.

Miss Yates was awarded the D.Lit. degree of the University of London in May for her work in the field of studies in the French and Italian Renaissance.

Miss Meredith resigned from the Photographic Collection at the end of the session on her appointment as Assistant Lecturer in Mediaeval Art at the University of Manchester. She will be succeeded by Mr. Michael Evans.

Research Fellows Dr. George Stričević (Institute of Archaeology, Belgrade) was awarded a Research Fellowship for one year for his work on the early history of the Christian liturgy. In the Easter vacation he attended the International Seminar on Byzantine Art at Ravenna and travelled to Turkey and Greece in connection with his research on the 'sigma'-shaped altar. He published an article on 'I monumenti dell'arte paleobizantina in rapporto con la tradizione antica e con l'arte medioevale nelle regioni centrali dei Balcani' in Zbornik, VIII, 2 (Mélanges Ostrogorski), and a paper on 'Drama as an Intermediary between the Scriptures and Byzantine Painting' which he read at the International Congress of the History of Art held in Bonn in September 1964 is in the press. Dr. Stričević has been appointed to a temporary Lectureship in Byzantine Art at the University of Edinburgh for the session 1965–1966.

Mrs. Roslyn Pesman (née Cooper), Junior Research Fellow for 1963-65, was awarded the Ph.D. degree in May for her thesis on 'Piero Soderini, gonfaloniere a vita of Florence, 1502-1512' (supervisors: Professor Gombrich and Professor Rubinstein). She resigned her Fellowship on 1 June on taking up permanent residence in Holland.

The Junior Research Fellowship for 1964–66 was awarded to Mr. Isaiah Shachar (Hebrew University of Jerusalem), who is writing a thesis for the Ph.D. degree on the emergence and dissemination of the modern Jewish stereotype in Western Europe (supervisor: Professor Gombrich). He received a grant from the Central Research Fund for photographic equipment. He spent the Christmas vacation in Jerusalem at the invitation of the Israel National Museum to arrange the permanent exhibition of its department of Jewish ceremonial art.

Mr. Simon G. Pembroke continued the work for which he was awarded a grant from the Saxl Fund on matriarchy in classical antiquity and its interpretation in the nineteenth and twentieth centuries, and which he hopes to complete soon for publication in the *Warburg Institute Surveys*. He will join the Department of Greek at Bedford College as Assistant Lecturer in October 1965.

Nuffield Foundation Commonwealth Research Fellowships Mr. James Longrigg, Nuffield Fellow for 1963–66, has continued his work on the Four Element Theory and is now preparing a first draft of the early chapters. He read a paper at the Ancient Philosophy Association Conference at Nottingham in March and wrote a note on 'Empedocles' Fiery Fish' for the Journal, XXVIII, 1965.

Dr. George H. Nadel, Honorary Nuffield Fellow, has been working on Bolingbroke and classical republicanism. He edited and introduced Studies in the Philosophy of History (Harper, New York, 1965) and contributed to the forthcoming International Encyclopaedia of the Social Sciences. He continues to act as editor of History and Theory.

Kress Foundation Fellowship During a visit to the Institute last year, Dr. F. S. Murphy, Chancellor of the University of California and President of the Samuel H. Kress Foundation, encouraged the Director to apply for the Institute's inclusion in the Foundation's fellowship programme for the further-

ance of art historical studies in America. The suggestion was that the Kress Foundation might make use of the potentialities of the Warburg Institute in order to help to train an American scholar; and that, following precedent, an award to an American scholar for this purpose might be linked with an additional grant to the Institute, to assist in developing its Library and Photographic Collection in connection with this scheme. In April the Trustees of the Kress Foundation voted to include the Institute in the Foundation's 'Graduate Fellowship Program in Art History'. This carries a grant for five years, half of which will provide stipends for a year's study at the Institute for an American student of art history, the other half to be given to the Institute for the expansion of its facilities, books, photographs, etc. with special reference to the needs of the Kress Fellow.

Permission by the University authorities enabled the Institute to accept this benefaction, unique in its annals, with gratitude and appreciation. An opportunity has thus been created for an American scholar to be attached to the Institute on the same terms as its own Senior Research Fellow. It is hoped that the Kress Fellows will benefit from the Institute's training and research facilities as much as their presence at the Institute will prove profitable and stimulating.

The first Kress Fellow to be chosen by the Selection Committee for the Kress Foundation Art History Fellowships of the Institute of International Education in New York is Mr. Ivan Galantic, who will come to the Institute in October 1965 to work on a central problem of the classical tradition, the sources and meaning of Leon Battista Alberti's theory of art.

The Course on the Civilization of the Italian Renaissance in the History School was taken Teaching and jointly by the Director, Dr. Kurz and Mr. Baxandall, supplemented by Dr. Montagu, Mr. members of Trapp and Dr. Walker. There were 11 first-year and 13 second-year students. The Course the Staff on the French Renaissance was taken by Dr. Walker. There were 3 first-year and 7 secondyear students, plus 3 postgraduates also attending the Course. Postgraduate seminars on an intercollegiate basis were held by the Director ('Cultural History?') and Professor Buchthal ('Illuminated Manuscripts'). A postgraduate study group, conducted by Dr. Ligota and Mr. Pembroke, held 18 meetings, to discuss theories of language from Dante to Humboldt.

The Postgraduate Course in Combined Historical Studies which the Institute has been planning to introduce is now scheduled to start in October 1966 as a two-year Course in Research Techniques leading to the new M.Phil. degree. It will centre at first on Renaissance studies, other options being planned for a later date.

Saxl Fund

The Deed of Covenant having expired in June 1964, Mr. E. S. de Beer informed the Director that he and his sisters, Miss M. L. de Beer and Miss D. H. de Beer, wished to renew their contributions to the Saxl Fund for a further term of eight years. The continuance of this very generous donation is recorded with sincere gratitude. The existence of the Saxl Fund, under the terms originally envisaged by the Founders, is of inestimable benefit to the Institute.

During the session the Trustees of the Saxl Fund authorized the award of a research grant for two years from October 1965, on the same terms as the Junior Research Fellowship, to Mr. Nabil Yahya Shehaby (University of Alexandria) for work on the Propositional Logic of Avicenna. Mr. Shehaby proposes to prepare an English translation together with a study of the text in the form of an introduction and commentaries on the section Al-Qiyās in Avicenna's Shifā'.

Library

3,690 books and pamphlets were added to the Library in the session 1964-65. This figure, though it is approximately the same as that for 1963-64, is misleadingly large. In the first place, it includes a very high percentage of sale catalogues and offprints, almost all of them presented by the institutions and private persons named below. These donors have also been most generous in presenting books, single volumes and runs of periodicals. Moreover, the Library has benefited greatly from the private libraries of two former Directors of the Institute, the late Professors F. Saxl and G. Bing. Nevertheless, the situation of the Library during the past session continued to deteriorate. Over fifty per cent of its allocation had to be spent on existing subscriptions to periodicals and serial publications—this in spite of an extensive and very valuable system of exchanges. Only a small fraction of the books that fall within the Library's scope could therefore be bought. The danger that essential books will go out of print before they can be acquired is acute.

In these circumstances the Library is especially grateful for the privilege, once more repeated, of selecting a number of urgently needed German publications, which were given

by the Deutsche Forschungsgemeinschaft through the Embassy of the Federal German Republic. Welcome gifts of pamphlets, books and periodicals were also received, as in previous years, from the Arts Council, the Austrian Institute, the Polish Cultural Institute, the French Cultural Attaché, and the Academies of Vienna and Budapest. The Library of the Jagellonian University of Cracow made a present of its publications, which has been of great value for the section on the history of universities in particular.

Among the large number of private donors mention should be made of P. Mario Borelli, the family of the late Tomás Harris, Mr. Ellic Howe, Dr. W. Pagel, Professor K. C. Pandey, Dr. J. K. Shearman and Professor P. Wittek.

A group of friends in England and in America has started a fund in memory of Professor Bing. It is hoped that thanks to this generous gesture the Library may in due course acquire some works close to her interests which it would otherwise not have been able to buy.

Grateful acknowledgement for voluntary help is made to Mrs. S. R. Foulkes.

Special thanks are due to Dr. Heimann for continuing to devote herself to the work of the Collection, in particular for organizing with Miss Meredith a photographic exhibition of the sculpture of Chartres mounted by Mr. Fein from photographs taken by Professor Zarnecki and Miss Pariser of the Courtauld Institute.

Work on the systematic photographing of etchings and engravings listed by Bartsch has occupied much of the Staff's time. Forty-eight albums of photographs were made for the Library. The proposal to extend the project was welcomed by most subscribers and the prints in the British Museum relating to Volume III have been photographed. Four new subscribers have joined the scheme: the Universities of California (Berkeley), Chicago and North Carolina (Chapel Hill), and the Prentenkabinett der Rijksuniversiteit, Leiden.

Many additions have been made to the Census of Antique Works of Art known to Renaissance Artists in collaboration with Mrs. Phyllis Bober of the Institute of Fine Arts of New York University. New documentary material was received from Mrs. Bober and accessions of photographs include the 'Bambaia' sketch-book (Berlin) and the Codex Ursinianus (Vatican).

An architectural sketch-book belonging to Mr. S. Kaufman was photographed for the Collection by kind permission of the owner.

The many other additions to the Collection include the photographs of Chartres made by the Courtauld Institute; photographs of the murals in the Salone Sistino, Biblioteca Apostolica Vaticana; photographs from the exhibitions of Zurbarán (Madrid) and European Art between Renaissance and Baroque (Manchester); an instalment of 500 photographs from the Netherlands Institute of Art History, The Hague; photographs of works of art in Great Britain acquired through the Courtauld Institute and the Scottish National Portrait Gallery.

Exchanges of photographs were made with the Courtauld Institute, the Kunsthistorisches Institut, Vienna, and Los Angeles County Museum of Art.

The Exhibition on the Visual Approach to the Classics was lent to several schools and there were many requests for the loan of other photographs for teaching purposes.

Grateful acknowledgement is made for gifts of photographs to the Conte di Sarre, Professor Buchthal, Messrs. Christie, Manson and Woods, Ltd., Messrs. Colnaghi, Messrs. Sotheby & Co., the Bowes Museum, Barnard Castle, and the Museo de Arte de Ponce, Puerto Rico.

Travelling

Mrs. Frankfort went to Madrid to see the Zurbarán Centenary Exhibition; and to Holland to study the iconographic indices and photographic collections of the Prentenkabinett in Leiden and the Institutes of Art History in The Hague and Utrecht.

Professor Gombrich gave the 'Invited Address' at the Annual Convention of the American Psychological Association, Los Angeles, in September 1964. As Walker Ames Professor at the University of Washington, Seattle, he held a course of public lectures on 'Ideals of Perfection in Art' and a seminar at the School of Art on 'Three Critical Notions: Style, Taste and Progress'. He also lectured at the University of Texas and at the University of Iowa.

Dr. Kurz took part in the symposium devoted to the Art Gallery of Prague Castle in June and lectured there on 'Künstlerische Beziehungen zwischen Prag und Persien zur Zeit Kaiser Rudolfs II. und Beiträge zur Geschichte seiner Kunstsammlungen'.

Mr. Trapp spent three weeks in Milan and Rome looking for material on the posthumous reputation of Sir Thomas More, and on the life of John Colet.

Father Cyril Barrett, S.J., conducted a seminar on 'Myth, Art and History' at the Institute. The History of Ideas Club has arranged to hold its meetings at the Institute.

Publications

The Cult of Childhood by Professor George Boas, which will be published as Vol. 29 of the Studies of the Warburg Institute, has gone to press.

The Italian edition of Professor Panofsky's Correggio's Camera di San Paolo (Studies, Vol. 28) is due for publication by Einaudi early next year.

The second of the Warburg Institute Surveys, Reichenau Reconsidered: A Re-assessment of its Place in Ottonian Art by Dr. C. R. Dodwell and Mr. D. H. Turner, was published in August 1965.

Professor Kristeller has compiled a long list of Addenda, covering all the Italian libraries, which will be published in the second volume of his Iter Italicum, now in final proof.

The fourth volume of the Catalogue of Astrological and Mythological Illuminated Manuscripts of the Latin Middle Ages, Dr. Patrick McGurk's Astrological Manuscripts in Italian Libraries (other than Rome), is in proof.

The reprint of the first volume of the Oxford-Warburg Studies, The Conflict between Paganism and Christianity in the Fourth Century, edited by Professor Momigliano, was ready in March. An Italian translation will be published by Einaudi next spring. The second volume, Mrs. A. C. Hanson's Jacopo della Quercia's Fonte Gaia, was published in February, and the third, Professor Ettlinger's The Sistine Chapel before Michelangelo. Religious Imagery and Papal Primacy, will be published in September 1965. The fourth volume, Professor Rubinstein's The Government of Florence under the Medici (1434-1494) is in final proof; an Italian edition, to be published by La Nuova Italia, Florence, is in preparation.

La Nuova Italia will also publish the Italian edition, now in final proof, of Warburg's writings, with an introduction by Professor Bing.

Vol. XXVII (1964) of the Journal was published in November. Once again the British Academy generously allocated a grant to the Journal which allowed the editors to improve the quality and quantity of illustrations.

Research

Dr. Barb wrote a chapter, 'Mystery, Myth and Magic', for the forthcoming new edition of The Legacy of Egypt (Oxford University Press), and a paper, 'Der Hütelberg bei Carnuntum', for the Gedenkschrift für Erich Swoboda.

Mr. Baxandall published 'Bartholomaeus Facius on Painting' in the Journal, XXVII, 1964, and 'A Masterpiece by Hubert Gerhard' in the Bulletin of the Victoria and Albert Museum, I, ii, 1965. The paper on 'Good and Bad Government: Mural Painting and Municipal Patronage in Siena' which he read to the Annual Conference 1965 of the National Society for Art Education will be printed in the Society's Journal.

Professor Buchthal has continued his work on Sicilian illumination of the thirteenth century. While attending the Dumbarton Oaks symposium in the spring he gave a lecture on this subject which will be published in the *Dumbarton Oaks Papers*. He re-worked for publication the lecture which he gave in Athens last year.

Mrs. Frankfort published a note on 'A Caritas Romana by Murillo' in the Journal, XXVII, 1964, and 'A New Book on Velázquez' in the Burlington Magazine, September 1964.

Professor Gombrich contributed to a discussion meeting convened by Sir Julian Huxley in June 1965 under the auspices of the Royal Society on "Ritualization of Behaviour in Animals and Man" with a paper on 'Ritualized Gesture and Expression in Art', which will be published in the *Proceedings* of the Royal Society, 1965. His Los Angeles address on 'The Use of Art for the Study of Symbols' was published in *The American Psychologist*, XX, 1, January 1965. He published 'Winston Churchill, Painter and Critic' in *The Atlantic Monthly*, March 1965, and 'The Beauty of Old Towns' in *The Architectural Association Journal*, April 1965. The Italian translation of *Art and Illusion* was published by Einaudi during the session.

Dr. Ligota's paper on 'L'influence de Macrobe pendant la Renaissance' which he read in Brussels has now been published in Le Soleil à la Renaissance. Colloque International tenu à Bruxelles en avril 1963.

Dr. Montagu is revising her thesis on 'Charles Le Brun's Theory of Expression' for publication. As a member of the Art History and Complementary Studies panel of the National Council for Diplomas in Art and Design she took part in visits of inspection.

Mr. Trapp published a note on 'Suavius olet: A Bronze Medal of Thomas More and its Motto', Moreana: Bulletin Thomas More, Nos. 5-6, 1965.

Dr. Walker has continued his work on Leibniz and Jesuit missionaries in China.

Dr. Yates wrote articles on 'Ramon Lull' for the New Catholic Encyclopaedia and on 'Hermeticism' and 'Giordano Bruno' for the Encyclopaedia of Philosophy. The manuscript of her book on The Art of Memory has been delivered to the publisher and will be published next year by Routledge and Kegan Paul and by the Chicago University Press.
